Executive Summary

Dogma Group Limited stands firmly against modern slavery in all its forms. This statement, published voluntarily under Section 54(1) of the Modern Slavery Act 2015, outlines our commitment to preventing slavery, servitude, forced labour, and human trafficking throughout our operations and supply chains.

Operating across the United Kingdom, Nepal, and India, we recognise the heightened risks in regions where an estimated eleven million people in India and 97,000 in Nepal are affected by modern slavery. We are committed to continuous improvement in identifying, assessing, and addressing these risks.

1. Our Commitment

Modern slavery is a crime against humanity that we will not tolerate within our organisation or supply chain. We pledge to:

- Respect and protect the fundamental human rights of all workers.
- Maintain transparent and ethical business practices.
- Continuously improve our approach to identifying and mitigating risks.
- Hold ourselves and our partners accountable to the highest standards.

This commitment extends to all Dogma Group companies, including our wholly owned subsidiary Dogma International.

5. Geographic Risk Analysis

India (Extreme Risk)

- Partnership with local organisations for ground-level insights.

- Advanced training for high-risk location managers.
- Board-level strategic workshops.
- Worker awareness programmes in local languages.

9. Governance and Accountability

- Annual independent assessment of programme effectiveness.
- Clear escalation procedures for identified risks.

Appendix: Key Definitions

Modern Slavery: Encompasses slavery, servitude, forced labour, debt bondage, and human trafficking.

Bonded Labour: Work demanded as repayment for a loan where terms prevent the debt from being paid off.

Debt Bondage: Status arising from a pledge of personal services as security for debt.

Harawa-Charuwa: Traditional bonded labour system in Nepal, now legally abolished.

Scheduled Castes/Tribes: Officially designated groups in India entitled to special protection due to historical discrimination.
